Our electric supplier has made changes in their fees for having meters turned off and back on. It will actually be cheaper for us to leave the power on now all winter for the campground. This means at the end of the camping season you will still have power at your camper. However, you will not receive an electric bill during the offseason, but you will see whatever usage you may have used over the winter months on your April bill.

This may be a benefit to everyone as it will allow you to keep your camper powered to have the battery charger

on the camper. Keeping your batteries up is important. You must have a good battery in your camper for some appliances, slides etc to work properly.

As always, if you want to ensure there is no electric usage you need to unplug your main power from the electric pedestal.

# Water is scheduled to be shut off to the campground on October 15th



A few winterizing reminders: Water will be shut off on October 15th, which

is a Tuesday this year, depending on the weather. Updates will be given through our alert system, so be sure to sign up.

While getting your campsite ready for old man winter don't forget to cap your sewer line and your blue tanks.

Fire wood must be stored off the ground per IL Department of Public Health rules.

**Question**: Can I have a fire in a fire pit after the water is turned off?

Answer: Yes, but it must be kept under control with someone over 18 keeping watch on the fire at all times. A bucket of water close by is highly recommended.



Question: Can I burn leaves?

Answer: Yes, but <u>not</u> after the water goes off. You can also put your leaves in brown paper bags and place them at the road by your camper and we will haul them away.

#### 2025 Invoices & Leases

Your lot leases and invoices are included with this newsletter. Be sure to get your lot leases signed and turned in to the bait shop office before November 1<sup>st</sup>.



A new lease <u>MUST</u> be signed each year and a current driver's license for each person listed on the lease

must be on file, failure to do so will jeopardize your lease.

The 1<sup>st</sup>installment for the 2025 season is due by November 1st, 2024. Remember there is a \$15 late fee per day for all late payments. Payments must be processed through our office by November 1st, meaning any payments that are sent through the mail or bank authorization payments that are received after November 1st will be subject to late penalties.
