

Queen of Hearts Raffle Rules

Otter Lake Park

- A. Player MUST be an individual, 21 or older, to purchase a ticket, to have their name on a ticket, and to win any prize.
- B. The raffle will take place weekly on Saturday at 7:00 p.m. (or any other time and day as determined by the Park Manager).
- C. Ticket sales end at 6:40 p.m. each Saturday (or any other time and day as determined by the Park Manager).
- D. All times are Central Standard times, as interpreted by the Park Manager.
- E. Tickets are \$1 / 1 ticket or \$5 / 6 tickets or \$20 / 30 tickets.
- F. Players will not be allowed to touch any equipment related to the raffle including, but not limited to, the display board, and ticket barrel.
- G. A single first and last name, and phone number are required on each ticket. A card location number is optional. Do not fold or tear tickets.
- H. You do not have to be present to win.
- I. If your ticket is drawn, and you are present, a card will be chosen based on the number you have written on the ticket. If no number was written on the ticket, you may choose any available card location.
- J. If your ticket is drawn, and you are not present, a card will be chosen based on the number you have written on the ticket. If no number was written on the ticket, or the number is illegible, the next available numbered envelope, starting with 1, will be chosen.
- K. If your ticket is drawn, you win the advertised prize for the card drawn.
- L. A revealed card is not eligible for future drawings. The revealed card will be displayed on the board in its original position on the board.
- M. The raffle is for individuals only, no exceptions.
- N. If the first and last names and the phone number written on the drawn ticket cannot be determined, the ticket will be deemed ineligible and a new ticket will be drawn. PLEASE PRINT LEGIBLY.
- O. A diligent effort will be put forth, within a reasonable amount of time, to contact the person who purchased the drawn ticket. If the individual does not respond within 6 days of the drawing any prize associated with that drawing will be forfeited.
- P. Every ticket drawn has an opportunity to win a prize. Every card that is not the Queen of Hearts will have value. The value for each card will be displayed ticket counter.
- Q. All prizes will be paid by check from the Otter Lake Water Commission.
- R. Payment of prizes in an amount greater than \$599 will be paid at a date / time / place agreeable between the winner and the Otter Lake Water Commission, and after any required tax forms are completed. You must prove your identity by presenting a government issued photo ID to claim this prize.
- S. All tickets in the barrel will be destroyed after each drawing.
- T. The jackpot amount for the next raffle will be determined following the end of the weekly raffle. The amount will be made public as soon as possible.
- U. After the next jackpot is announced, tickets will be available for sale for the next raffle.
- V. All state and federal tax laws apply and will be followed. Winners must provide their tax information (SSN), where applicable, to receive their prize.
- W. The Otter Lake Water Commission reserves the right to modify these rules and will remain in compliance with all laws (federal, state, county, city).
- X. The Otter Lake Water Commission reserves the right to cancel a weekly drawing. Tickets from a cancelled drawing will remain in the barrel for the next drawing.

Card Values

Queen of Hearts – 50% of the pot.

Joker – 20% of the pot or \$200, whichever is less.

Ace – 15% of the pot or \$150, whichever is less.

Face Cards (other than Queen of Hearts) – 10% of the pot or \$100, whichever is less.

All other cards – 5% of the pot, or \$50, whichever is less.
